**MOTION FOR INCENTIVE AWARDS TO CLASS REPRESENTATIVES**

Plaintiffs, by and through undersigned class counsel, file this Motion for Incentive Awards to Class Representatives based upon their assistance to class counsel and the class in the prosecution of this litigation. In support thereof, Plaintiffs state as follows:

1. Joan Light, Shirley Eisenberg, Carol Prisco, and Gloria Zimmer were appointed by the Court as Class Representatives.
2. In their role as Class Representatives, they greatly assisted class counsel in investigating, preparing, and bringing this claim.
3. The Class Representatives have also assisted in discovery and have all given of their time to class counsel when needed, responded to interrogatories, had their depositions taken, and testified as needed.

4. Incentive awards are common in class action litigation, especially when a common fund is created. *In re S. Ohio Correctional Facility*, 175 F.R.D. 270, 273 n.3 (S.D. Ohio1997) (citing a multitude of cases granting incentive award to class representatives). “Courts routinely approve incentive awards to compensate named plaintiffs for the services they provided and the risks they incurred during the course of the class action litigation.” *Id.*

5. Indeed, “a named plaintiff is an essential ingredient of any class action, an incentive award can be appropriate to encourage or induce an individual to participate in the suit.” *In re Compact Disc Minimum Advertised Price Antitrust Litigation*, 292 F.Supp.2d 184, 189 (D. Maine, 2003).

6. The additional compensation to class members is justified when the class representatives expend time and effort beyond that of the other class members in assisting class counsel with the litigation. *In re S. Ohio Correctional Facility*, 175 F.R.D. at 273. Ms. Light, Eisenberg and Prisco have assisted class counsel with the prosecution of this case before the case was filed, giving of their time, experience and effort, in the successful resolution of this matter. Ms. Zimmer became a Class Representative shortly after the case was filed, also giving of her time, experience, and effort, in the successful resolution of this matter.

7. Class counsel request incentive awards in the amount of \$250,000.00 for each of the Class Representatives in this matter.

WHEREFORE, class counsel request that the Court enter an order granting incentive awards in the amount of \$250,000.00 to the Class Representatives in this matter.
