- 3. I may file and pursue my own claim for compensatory monetary damages, unless it is barred by an applicable statute of limitations; and
- 4. The Court has made no determination whether or not I will be allowed to share in the punitive damage settlement in this case or whether or not I will be allowed to pursue a separate claim for punitive damages (whether already filed or not) even though I have opted-out of the class.
